- ELIGIBILITY** To be eligible for "OPEN" QUALIFYING, applicants must be a professional or an amateur with a certified handicap index of 2.0 or less. **FIELD IS LIMITED TO 156 PARTICIPANTS**
- RULES** Play will be governed by the 2006-07 USGA Rules of Golf and where applicable, by the Local Rules and Conditions set forth by the PGA TOUR. Questions shall be settled by the designated Rules Committee, whose decision shall be final. Individual 18 Hole Stroke Play will be the format.
- ENTRY FEE** **\$350.00** for **NON-MEMBERS** of the **PGA/NATIONWIDE TOUR**. **\$100.00** for **PGA/NATIONWIDE TOUR MEMBERS**. **ENTRY FEE IS PAYABLE BY CASH, CASHIERS CHECK, MONEY ORDER, TRAVELER'S CHECK . NO PERSONAL CHECKS WILL BE ACCEPTED.** The Western New York PGA will apply all tournament proper entry fees from qualifying entry fee for all successful qualifiers. **MAKE PAYMENT PAYABLE TO THE WESTERN NEW YORK SECTION PGA.**
- ENTRIES CLOSE** Entries for the "OPEN" Qualifying must be received at the Western New York PGA office by 5:00 PM E.D.T. on Wednesday, August 2, 2006. Entries late or incomplete are not acceptable. **Telephone or Faxed entries will NOT be accepted.** The Western NY PGA is not responsible for the timely performance of the U.S. Postal Service or any other delivery service.
- STARTING TIMES** Starting times for the "OPEN" Qualifying will be available by calling the Ravenwood GC after 8:00 AM on Saturday, August 5, 2006 at (585) 924-5100. Written confirmations of starting times will NOT be sent. Requests will NOT be granted.
- APPEARANCE** Players and caddies shall present a neat appearance in both clothing and personal grooming. Blue jeans or shorts shall NOT be worn during the practice rounds or "OPEN" Qualifying round by the players. Caddies may wear either long pants (*no blue jeans or cut-offs*) or tailored solid colored knee length shorts, and caddies must wear smooth rubber sole shoes (*golf shoes with traditional metal or soft spikes are prohibited for caddies*).
- CONDUCT** A player or caddie conducting himself in a manner unbecoming a professional, found to be using or selling illegal substances, or using alcohol in an abusive manner could result in the removal of the player from the competition for conduct unbecoming a professional.
- GOLF CARTS** During Open Qualifying: Golf Carts are not permitted. Players and caddies shall walk at all times, except when permitted by the Rules Committee to ride. Players are not required to have a caddie. Players and caddies may either carry the clubs or use a manual or electric pull cart. Anyone seeking a golf cart due to a disability defined under the Americans With Disabilities Act (ADA) should contact the PGA TOUR's Competition Department at (904) 285-3700 to obtain information and procedures for submitting requests. All such requests and required information must be submitted to the PGA TOUR no less than 30 days prior to the competition. Please note that requests due to temporary injuries or impairments that do not qualify as a "disability" under the ADA will not be granted.
- REFUND POLICY** Refunds will be given only in the case of injury or other disability which requires medical attention, serious personal emergency, if a player becomes eligible for a Nationwide Tour or PGA TOUR event, or any other situation covered by the Nationwide Tour Tournament Regulations. NO other refunds will be given.
- PRACTICE** Call Mike Roeder at Ravenwood GC at (585) 924-5100 to arrange a practice round.
- QUALIFYING SPOTS** There will be a minimum of four (4) qualifying spots with normally fourteen (14) spots available. Any ties for the final qualifying spot(s) or alternate positions (10) will be settled by a sudden-death playoff (playoff hole(s) to be determined by the Rules Committee) immediately following the conclusion of play.
- EVENT PROPER** The 2006 Nationwide Xerox Classic will be played August 10-13, 2006 at Irondequoit CC in Rochester, NY.
